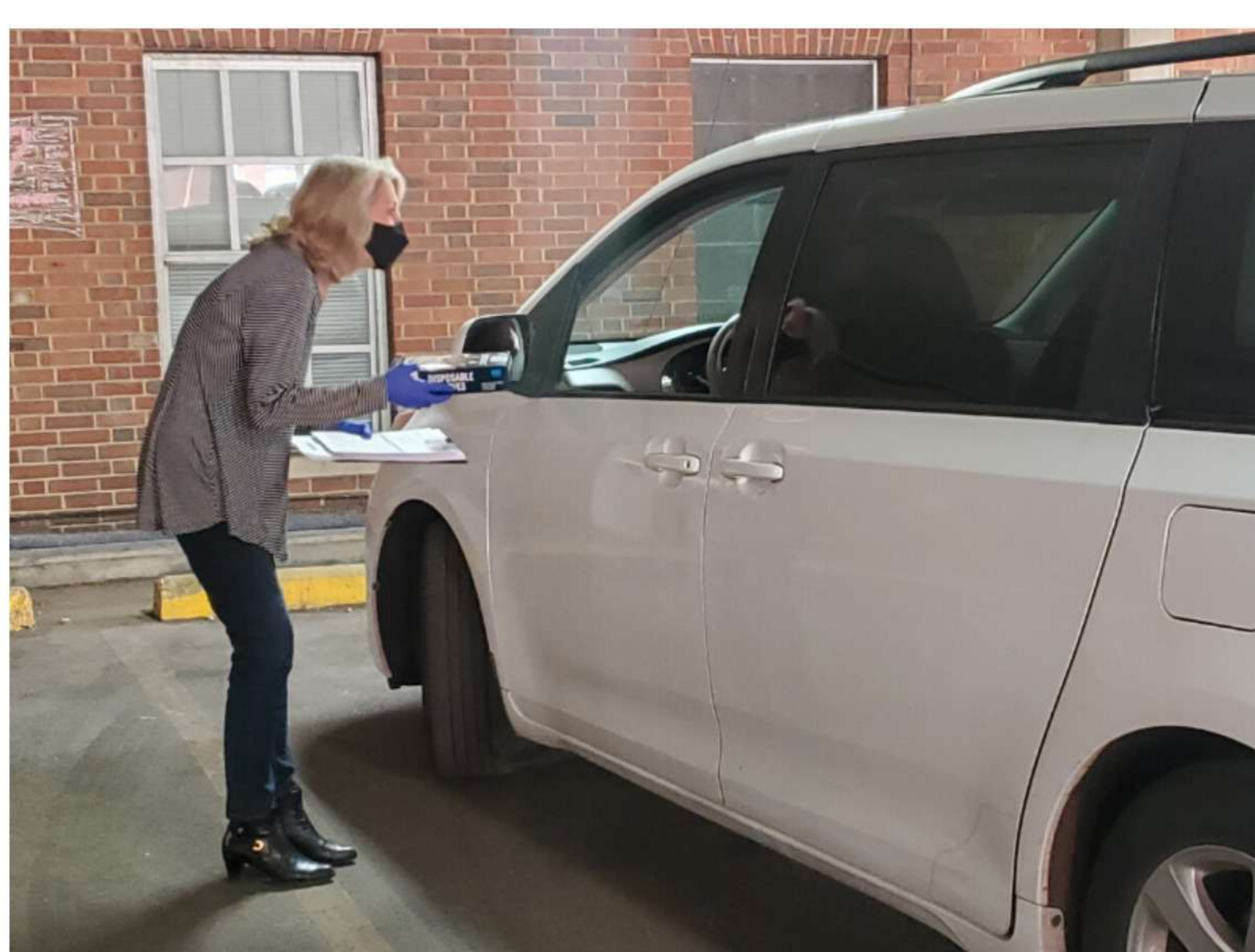
### Looking Ahead to Summer

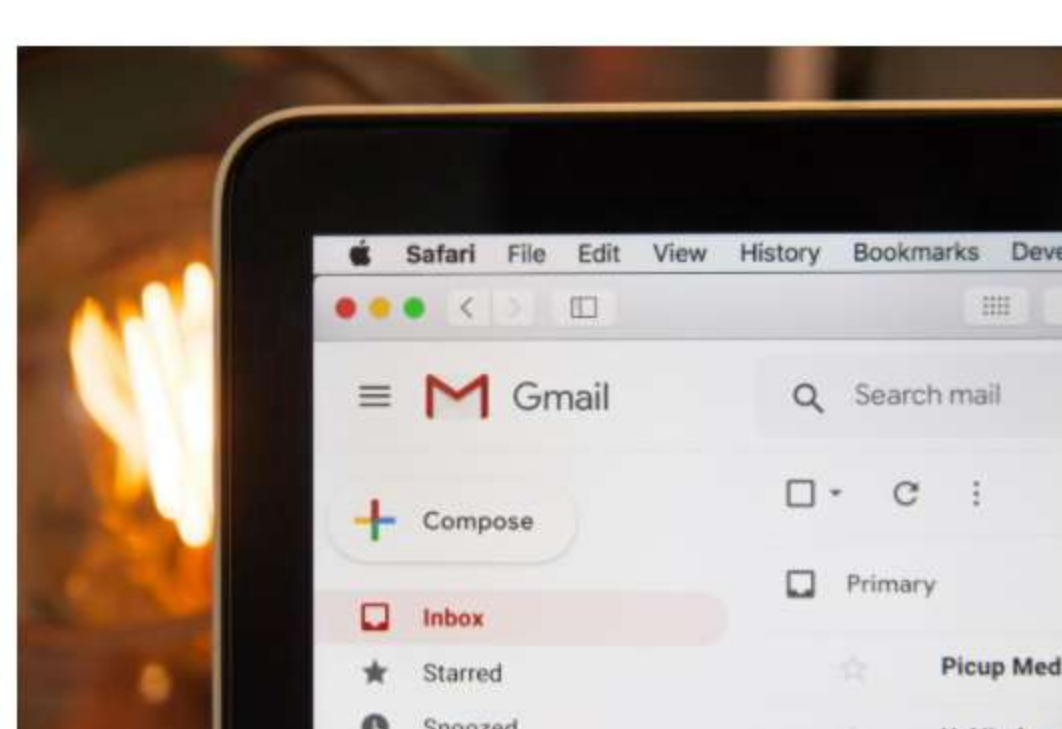
